OKRA Board Meeting Minutes - June 17, 2016 Conference Call

Committee Reports

<u>Membership</u> – Ilda said that Batliner renewed their membership. This was the only membership activity we have had.

Ilda proposed not doing a membership drive for 2016 and allow anyone that has renewed or joined in 2016 be carried over into 2017. This would mean members from 2015 will still be members until our next membership drive in early 2017. <u>Nominations</u> – Sara sent a draft based on the New Mexico model to the Nominations Committee. Tracey has been out of town and has not had time to review it.

Ellen has volunteered to call current board members to check status of willingness to continue to serve and in what capacity. Ellen will do this by the end of June. Once we have identified how many open positions we have, then we will do a call for nominations. Traci asked that the call for nominations go out no later than July 8th and July 29th could be the deadline to receive nominations back. Tracey will set up a meeting to work on the specifics and timeline.

<u>Advocacy</u> - No report. Ilda said reading the last minutes, Daniel's idea of contacting county commissioner's sounds like a great idea. Ilda said she will get a list and send it to Daniel.

<u>Education</u> – No update. Sara said the schools that were nominated by Lynn previously were in the last OKRA newsletter. That was great.

Market Development - No update.

<u>Materials Exchange</u> – No update. Ilda asked about the P2 program getting more involved. Sara said she spoke with Dianne about it, but P2 cannot commit to that at this time. There was also discussion about Christine Allison perhaps becoming involved in this committee.
